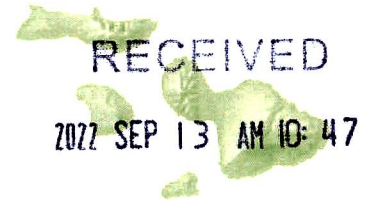
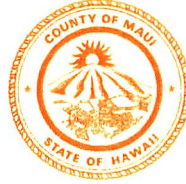

**SUBJECT: PROPOSED RESOLUTION AUTHORIZING THE MAYOR TO
EXECUTE GRANT G5808 TO KĪPAHULU OHANA, INC. FOR
THE PURCHASE OF PROPERTY AT KĪPAHULU, HAWAII**

I am transmitting a proposed resolution entitled "AUTHORIZING THE USE OF OPEN SPACE, NATURAL RESOURCES, CULTURAL RESOURCES, AND SCENIC VIEWS PRESERVATION FUNDS BY GRANT TO KĪPAHULU OHANA, INC. TO BE USED TO PURCHASE PROPERTY IN KĪPAHULU, MAUI, HAWAII, AND AUTHORIZING THE COUNTY TO RECEIVE A PERPETUAL CONSERVATION EASEMENT."

The purpose of the proposed resolution is to authorize the Mayor to execute Grant G5808 from the Open Space, Natural Resources, Cultural Resources, and Scenic Views Preservation Funds to Kipahulu Ohana, Inc. The grant provides \$2,500,000 to acquire approximately 9.5 acres in Kipahulu, Maui, Hawaii, identified as Tax Map Key No. (2)1-6-101:005. Funds are appropriated for the grant. A copy of page 55 of the Fiscal Year 2023 Budget Ordinance is attached for your reference.
