A BILL FOR AN ORDINANCE AMENDING APPENDIX A  
OF THE FISCAL YEAR 2023 BUDGET FOR THE COUNTY OF MAUI  
AS IT PERTAINS TO PART II, SPECIAL PURPOSE REVENUES -  
SCHEDULE OF REVOLVING/SPECIAL FUNDS FOR FISCAL YEAR 2023,  
ECONOMIC DEVELOPMENT AND CULTURAL PROGRAMS  
REVOLVING FUND (MOLOKAI GLASS HOUSE AT MAPULEHU)

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5392, Bill No. 69, CD1, FD2 (2022), as amended, "Fiscal Year 2023 Budget", Appendix A, Part II, Special Purpose Revenues – Schedule of Revolving/Special Funds for Fiscal Year 2023, is hereby amended as it pertains to the Economic Development and Cultural Programs Revolving Fund, by adding an appropriation for the Molokai Glass House at Mapulehu in the amount of \$250,000, to read as follows:

FOR FISCAL YEAR 2023**



(1) Up to \$150,000 must be for the Maui Historical Society for the repairs and renovations at the Bailey House Museum and accessory buildings.			
(2) Up to \$150,000 must be for the restoration of Ka`ahumanu Church, Wailuku, Maui, Hawaii.			
(3) Up to \$1,500,000 must be for acquisition of approximately 0.930 acres and all of the buildings and structures located thereon, identified as Tax Map Key No. (2) 3-3-003- 006 and approximately 0.498 acres, identified as Tax Map Key No. (2) 3-3-003- 008, located on Iao Valley Road, Wailuku, Maui, Hawaii.			

(4) Up to \$250,000 to develop and implement a burial treatment plan, and a preservation and access plan for the Molokai Glass House at Mapulehu, a County owned property."
