**SUBJECT: AMENDMENTS TO THE FISCAL YEAR 2023 BUDGET  
(DEPARTMENT OF WATER SUPPLY, WEST MAUI  
RELIABLE CAPACITY)**

On behalf of the Department of Water Supply, I am transmitting the following:

1. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2023 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO ESTIMATED REVENUES; DEPARTMENT OF WATER SUPPLY, WEST MAUI COMMUNITY PLAN AREA, WATER SUPPLY, WATER FUND – RESTRICTED, WATER FUND – UNRESTRICTED, WEST MAUI RELIABLE CAPACITY; TOTAL CAPITAL IMPROVEMENTS PROJECT APPROPRIATIONS; TOTAL APPROPRIATIONS (OPERATING AND CAPITAL IMPROVEMENT PROJECTS)."

The purpose of the proposed bill is to amend the FY 2023 Budget by increasing the estimated revenues from Special Assessments by \$10,000,000 and from Carryover Savings from the Water Fund by

\$7,200,000; and appropriating the funds to the Department of Water Supply, West Maui Community Plan Area for the West Maui Reliable Capacity.

2. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2023 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX C – CAPITAL IMPROVEMENT PROJECTS, DEPARTMENT OF WATER SUPPLY, WEST MAUI COMMUNITY PLAN AREA, WEST MAUI RELIABLE CAPACITY."

The purpose of the proposed bill is to amend Appendix C of the FY 2023 Budget by increasing the appropriation for the West Maui Reliable Capacity by \$17,200,000 and adding a project to the project description.

3. A Certification of Additional Revenues for Carryover/Savings from the Water Fund for \$7,200,000.

The original bid of \$12,881,675 was received in December 2019 however because of bid protests, the Department was not able to contract with Alpha. The Department is in receipt of Alpha's best and final offer dated September 28, 2022 in the amount of \$15,886,309.17. The COVID pandemic, the war in Ukraine, the material supply-chain, energy inflation, fuel costs, and material escalations contribute to the increase in the project construction.

The Department has obtained the State Historic Preservation Division approval on March 16, 2022; and the Commission on Water Resource Management (CWRM) approval on the pump installation permit on August 10, 2022. Upon receipt of approval from CWRM, the Department negotiated a best and final offer from the contractor and is ready to proceed with construction.

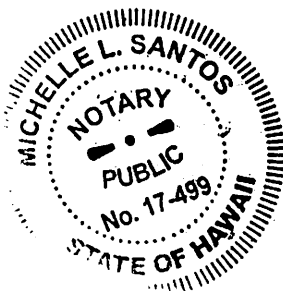
