Support for PROHIBITION OF FEEDING FERAL ANIMALS

Aloha mai kākou,

On behalf of the Maui Conservation Alliance (MCA), we would like to voice our support for amending the Maui County Code, Chapter 6.04.040, relating to feeding feral animals. We support the new definition of "feral animal" and adding the new section "6.04.041 Feeding of feral animals prohibited."

Feeding of feral animals causes changes to animal behavior by making them dependent upon feeding by people, and causes concentrations of these animals. Concentrations of animals pose health and safety threats to native wildlife as well as humans. These include (but are not limited to) spread of disease (such as toxoplasmosis), predation on and disturbance to native wildlife, aggression by concentrated animals with other each other, other animals, and humans.

Specific examples include: predation by feral cats and rodents on native birds such as the endangered nēnē (Hawaiian goose), and native 'ua'u kani (Wedge-tailed shearwater) which are found near harbors; and mortality of endangered nēnē and endangered Hawaiian monk seals from disease such as toxoplasmosis. Additionally, our members have observed feral cats and mongooses being very aggressive with humans in areas where they are fed illegally.

We appreciate the opportunity to support amendments to protect native wildlife species and people. If you have any questions or want additional details, please don't hesitate to contact us.
