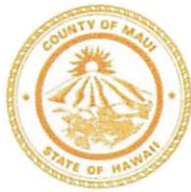

SUBJECT: SPECIAL MANAGEMENT AREA REVOLVING FUND

Ordinance No. 4882 took effect on July 1, 2019 and established the Special Management Area (SMA) Revolving Fund through Chapter 3.49 of the Maui County Code. Section 3.49.030.D. requires the Planning Department to transmit to the County Council a detailed report of the SMA violations and amount of fines collected. These fines, along with SMA and shoreline-related permit application fees, are deposited into the SMA fund (account no. 101148).

Attached please find a report of fines since the inception of the fund on July 1, 2019. Calendar year 2019 only includes a single fine; there may have been others collected in the first half of the year that were deposited into the general fund. Calendar years 2020 and 2021 show fines collected during those years.

We understand the Code requires transmittal of this information on or before March 1 of each year; however, personnel from the Departments of Planning and Finance and IT Services Division spent a considerable amount of time this year researching payments, correcting entries that were erroneously deposited to the general fund, and fixing the EnerGov permitting system and the iNovah cashiering system to ensure payments would be processed correctly going forward. Future reports should be delivered to the Council on time.
