WHEREAS, the 240 pairs of footwear are donated to provide protective footwear for all ocean safety officers employed in the lifeguard division; and


WHEREAS, Chapter 3.56, Maui County Code, authorizes the Council to accept gifts and donations on behalf of the County; now, therefore,
