Please indicate why you are interested in serving and what skills you may have to contribute:

I am interested in serving on the Maui Board of Water Supply (BWS) because I would like to lend my skills and experience in better fulfilling BWS' mission by bringing it in line with Hawai'i's unique legal regime under the public trust. I also truly believe, in order for Maui to be truly "no ka 'oi", to put its best foot forward, there is a unique opportunity to set a gold standard for other municipal water purveyors in Hawai'i. I am also interested in fulfilling the kuleana, "responsibility and privilege" of stewarding our public trust resources, such as water, for present and future generations. Because the Hawai'i Supreme Court has held that all of Hawai'i's water resources are held in trust, Board members have a fiduciary duty not only to balance a range of interests, but must analyze their kuleana under the laws that BWS is charged with implementing and enforcing.

My formal legal education and experience in Hawai'i's unique water and public trust laws and policy issues, cultural grounding, and lived experience are the skills I plan to contribute to my work on the BWS.
