BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:



This bill proposes to amend Ordinance No. 5392, Bill No. 69, CD1, FD2 (2022), the "Fiscal Year 2023 Budget" of the County of Maui, by amending Appendix B, "Revenues – Fees, Rates, Assessments and Taxes", as it pertains to the Department of Finance, Special Revenue/Trust and Agency Fund, Highway Beautification, by increasing the fee for U-drive motor vehicles from \$1 to \$10, effective January 1, 2023.
