AUTHORIZING SETTLEMENT OF GERALDINE CONSTANTINO VS. COUNTY OF MAUI, DISABILITY COMPENSATION DIVISION CASE NO. 7-17-00763

WHEREAS, Claimant Geraldine Constantino, filed a Workers' Compensation Claim alleging work related injuries sustained on May 10, 2017; and

WHEREAS, having reviewed the facts and circumstances regarding this matter and being advised of the proposed settlement by the Department of the Corporation Counsel, the Council wishes to authorize the settlement of the Workers' Compensation Claim under the terms and conditions proposed in an executive meeting before the Government Relations, Ethics, and Transparency Committee; now therefore,

BE IT RESOLVED by the Council of the County of Maui:

- 1. That it hereby approves settlement of Geraldine Constantino vs. County of Maui, Disability Compensation Division Case No. 7-17-00763, under the terms set forth in an executive meeting before the Government Relations, Ethics, and Transparency Committee; and
- 2. That it hereby authorizes the Mayor to execute a Stipulation and Settlement Agreement on behalf of the County in this case;

- 3. That it hereby authorizes the Director of Finance of the County of Maui to satisfy said settlement of this case, under such terms and conditions as may be imposed, and agreed to, by the Corporation Counsel; and
- 4. That payment is authorized to satisfy this settlement following approval of the Stipulation and Settlement Agreement by the Department of the Labor and Industrial Relations, State of Hawaii; and
- 5. That certified copies of this resolution be transmitted to the Mayor, the Director of Finance, the Director of Housing & Human Concerns, and the Corporation Counsel.
