## REMOVAL OF ROBERT HALE PAHIA FROM THE KULA AGRICULTURAL PARK COMMITTEE FOR THE COUNTY OF MAUI

WHEREAS, by correspondence dated September 23, 2022, Mayor Michael P. Victorino recommended the removal of member Robert Hale Pahia from the Kula Agricultural Committee (the "Committee") for the County of Maui due to member non-compliance; and

WHEREAS, Mr. Pahia was appointed to the Committee by Resolution 22-60, FD1, adopted on May 26, 2022 for a term expiring on March 31, 2027; and

WHEREAS, Mr. Pahia failed to return the necessary paperwork to complete his appointment to the Committee; and

WHEREAS, Section 13-2(5) of the Revised Charter of the County of Maui (1983), as amended provides that members of boards and commissions appointed by the Mayor, with the approval of the Council may be removed for cause upon recommendation of such removal by the Mayor and the approval of two-thirds of the entire membership of the Council; now, therefore

BE IT RESOLVED by the Council of the County of Maui:

1. That it hereby approves the removal of Robert Hale Pahia from the Kula Agricultural Committee for the the County of Maui;
2. That such removal shall be effective upon adoption of this resolution;
3. That certified copies of this resolution be transmitted to the Mayor and the Managing Director.
