Chair and Members:

Your Budget, Finance, and Economic Development Committee, having met on November 2, 2022, makes reference to Bill 150 (2022), entitled "A BILL FOR AN ORDINANCE AMENDING TITLE 3, MAUI COUNTY CODE, RELATING TO THE ESTABLISHMENT OF A PARKING REVENUE FUND."

Bill 150's purpose is to amend Title 3, Maui County Code, to establish a Parking Revenue Fund to generate funding for the County's parking operations, including maintenance, repair, security, safety, improvement, equipment, beautification, expansion, staff compensation, parking facility bond payments, and other related costs.

Your Committee noted the Council passed Bill 151, CD1 (2022) on first reading at its meeting of November 4, 2022. Bill 151, CD1, authorizes a Parking Ambassador Program to assist the Department of Transportation with enforcing County and State parking rules and laws, and implementing a parking payment system. Funds for the Parking Revenue Fund would be generated by paid parking zones and permit parking zones if Bill 151, CD1, is enacted.

A representative from the Department of Management confirmed that any surplus funds may be used for maintaining or improving County parks; expanding and enhancing public transportation, pedestrian, and bike infrastructure or programs; improving safety, wayfinding, or maintenance of neighborhood business districts; and protecting and acknowledging sensitive cultural and environmental sites.

BILL NO. 150 (2022)

A BILL FOR AN ORDINANCE AMENDING TITLE 3, MAUI COUNTY CODE,
RELATING TO THE ESTABLISHMENT OF A PARKING REVENUE FUND

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Title 3, Maui County Code, is amended by adding a new chapter to be appropriately designated and to read as follows:

"Chapter 3.31

PARKING REVENUE FUND

Sections:

- 3.31.010 Fund establishment.**
- 3.31.020 Purpose.**
- 3.31.030 Deposits to the fund and use.**
- 3.31.040 Administration.**

3.31.010 Fund establishment. There is established and created a revolving fund to be known as the "parking revenue fund."

3.31.020 Purpose. A. The parking revenue fund is established primarily for the purpose of providing funding for the County's parking operations, including maintenance, repair, security, safety, improvement, equipment, beautification, expansion, staff compensation, parking facility bond payments, and other costs related to providing County parking services. Once those costs have been fully met, any surplus monies within the fund may also be used for the purposes described in subsection 3.31.020(B).

B. Surplus monies from the parking revenue fund may only be applied towards the following types of projects:

1. Maintaining or improving County parks.
2. Expanding and enhancing public transportation, pedestrian, and bike infrastructure or programs.
3. Improving safety, wayfinding, or maintenance of neighborhood business districts.

4 Protecting and acknowledging sensitive cultural and environmental sites.

3.31.030 Deposits to the fund and use. A. There shall be deposited into the parking revenue fund all fees collected from County paid parking, including revenue from parking payment devices, parking permits, and parking citations.

B. The revenues in the parking revenue fund shall not be used for any purpose except for those listed in section 3.31.20.

C. The department of transportation is responsible for the management of the parking revenue fund.

3.31.040 Administration. A. The director of finance must establish a separate account to record all revenues derived from County paid parking and expenditures made from the parking revenue fund.

B. Expenditures made from the parking revenue fund must be through budget appropriations."


SECTION 2. This Ordinance takes effect on approval.
