RELATING TO THE APPOINTMENT OF RICKY AARON SANCHES, SR. TO THE URBAN DESIGN REVIEW BOARD FOR THE COUNTY OF MAUI

WHEREAS, by correspondence dated April 29, 2022, Mayor Michael P. Victorino notified the Council he nominated Ricky Aaron Sanches, Sr. to the Urban Design Review Board for a term expiring March 31, 2023, to fill a vacancy replacing Stuart Marlowe, in accordance with Section 2.26.030, Maui County Code, and Section 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and

WHEREAS, Charter Section 13-2 requires the Mayor's nominee to be approved by the Council; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

- 1. That it approves the appointment of Ricky Aaron Sanches, Sr. to serve on the Urban Design Review Board for a term expiring March 31, 2023;
- 2. That the Council expresses its gratitude and appreciation to Ricky Aaron Sanches, Sr. for his willingness to be considered for public service and actively participate in County government; and
