A BILL FOR AN ORDINANCE AMENDING SECTION 3.04.020, MAUI COUNTY CODE, RELATING TO SUBMITTAL OF THE OPERATING BUDGET AND CAPITAL PROGRAM

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 3.04.020, Maui County Code, is amended to read as

follows:

"3.04.020. General. A. The minimum disclosures required in this chapter [shall] <u>must</u> not be interpreted to restrict any County agency from making additional or more detailed disclosures.

B. Information transmitted as required by this chapter [shall] <u>must</u> include a disclosure of the specific fund or funds involved, where appropriate.

C. Preparation of the operating budget and capital program [shall] <u>must</u> implement, to the extent practicable, the County's general plan enacted [pursuant to] <u>under</u> chapter 2.80B of this code.

D. The annual submittal by the mayor to the council of the operating budget and capital program must be made by 9:00 a.m. on the day specified in the charter."

SECTION 2. New material is underscored. In printing this bill, the County

Clerk need not include the underscoring.

SECTION 3. This Ordinance takes effect upon its approval.
