Chair and Members:

Your Government Relations, Ethics, and Transparency Committee, having met on November 15, 2022, makes reference to the following:

- 1. County Communication 21-42, from Council Chair Alice L. Lee, relating to nominations to boards, committees, and commissions.
- 2. Resolution 22-225 entitled "APPOINTMENT OF A MEMBER TO THE URBAN DESIGN REVIEW BOARD FOR THE COUNTY OF MAUI."

Resolution 22-225's purpose is to approve or disapprove the Mayor's nomination of Ashley Noelani Mikie Otomo to the Urban Design Review Board, for a term expiring March 31, 2027.

By correspondence dated October 10, 2022, the County Clerk transmitted a letter from the Mayor, dated September 19, 2022, and received on September 20, 2022, with a completed application for the nominee.

Your Committee notes general appointment procedures for boards, committees, and commissions are outlined in Section 13-2, Revised Charter of the County of Maui (1983), as amended, and Chapter 2.41, Maui County Code.

Your Committee further notes specific provisions for the Urban Design Review Board are located in Sections 2.26.030 and 2.40.100, Maui County Code.

There is no time limit for the Council to approve or disapprove the nomination.

Your Committee interviewed Ms. Otomo.

According to her application, Ms. Otomo is the Executive Vice President of Otomo Engineering, Inc. and is a member of the National Association of Realtors, National Society of Professional Engineers, and Girl Scouts of America.

Her application also notes she received a Master of Science in Civil Engineering from the University of California, Los Angeles ("UCLA") and a Master of Business Administration from UCLA's Anderson School of Management.

Ms. Otomo feels that serving on the Urban Design Review Board is a way to give back to the community. As a civil engineer, her projects have gone through the Urban Design Review Board process and she is familiar with the issues the Board faces.

Your Committee expressed concern with possible conflicts of interest. Ms. Otomo said she is willing to recuse herself, if needed.

A representative from the Office of the Mayor said it has been challenging to find registered civil engineers to fill vacancies. Section 2.26.030(B) requires that of the board's nine members and four alternates, two members must be registered civil engineers. If approved, Ms. Otomo would fulfill this requirement.

Your Committee is in receipt of Resolution 22-225, CD1, approved as to form and legality by the Department of the Corporation Counsel, incorporating your Committee's recommended revisions and nonsubstantive revisions.
