

As a Deputy Attorney General, she supervised the agency's Maui operations and did so in an extraordinary manner. 

Andy is also dedicated to the well-being of his team and has devoted considerable effort to strategic planning,


training on a variety of topics with notable subject matter experts and wellness in the workplace.






