

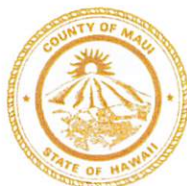

On behalf of the Department of Finance, I am transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2023 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX A, PART I, GRANTS AND RESTRICTED USE REVENUES – SCHEDULE OF GRANTS AND RESTRICTED USE REVENUES BY DEPARTMENTS AND PROGRAMS, DEPARTMENT OF FINANCE (LOCAL ASSISTANCE AND TRIBAL CONSISTENCY FUND (LATCF))."

The purpose of the proposed bill is to amend Appendix A, Part I of the Fiscal Year 2023 Budget by adding a new grant entitled "Local Assistance and Tribal Consistency Fund (LATCF))" for \$50,000.

Funds were made available from the U.S. Department of the Treasury for eligible tribal governments and eligible revenue sharing counties. The funds shall be used to support a strong and equitable economic recovery. The Department of Finance applied for the grant and was awarded \$50,000.
