Your Committee notes general appointment procedures for boards, committees, and commissions are outlined in Section 13-2, Revised Charter of the County of Maui (1983), as amended, and Chapter 2.41, Maui County Code.

The Mayor is required to submit names of nominees to the Council not less than 60 days and not more than 70 days before the prior members' terms expire. If the Council fails to approve or disapprove any of the Mayor's nominees within the time period provided, the nominee will be deemed appointed to fill the vacancy. If the Council disapproves a nominee, the Mayor will be notified immediately.

Accordingly, the Council has until March 31, 2023, to approve or disapprove the Mayor's nominees, or the nominees will be deemed appointed.

By correspondence dated February 9, 2023, the Mayor informed your Committee that Liquor Control Adjudication Board nominee Kaulana Mossman withdrew from consideration. By correspondence dated February 21, 2023, the Mayor informed your Committee that Maui Planning Commission nominee Sheila Walker withdrew from consideration.

Your Committee received introductions to the nominees from the Mayor's representative. Your Committee interviewed two individuals as nominees for the Affirmative Action Advisory Council and the Lāna'i Planning Commission.

Your Committee expressed concern with Affirmative Action Advisory Council nominee Melissa Navarro Will's incomplete application. She clarified that the information was accurate regardless of a lack of signature, including not listing a political affiliation. Your Committee was satisfied with the nominee's response but requested an updated application, as well as from other nominees whose applications were dated 2022 and earlier.

Your Committee interviewed Lāna'i Planning Commission nominee Jay S. Margulies. Despite the nominee's explanation of his involvement in the Lāna'i community, your Committee expressed concern regarding the length of his residency on Lāna'i and stated a preference to fill the vacant seat with a cultural expert.

Regarding Fire and Public Safety Commission nominee Luke Makani Bailey, your Committee discussed the nominee's recent resignation from the Commission. Your Committee requested the nominee be present at the Council meeting to explain his change in availability and willingness to be a member of the Commission.

The Mayor's representative confirmed Molokai Planning Commission nominee John R. Sabas did not meet the residency requirement under Section 2.28.050, Maui County Code, which states "to

be eligible for appointment as a member or alternate of an advisory committee, a person must be a resident of the relevant community plan area for a period of at least twelve consecutive months immediately preceding the person's appointment."

He also confirmed that nominees who applied to more than one board or was already a member of a board being nominated to another were made aware of the time commitment. He further confirmed they would be able and willing to accommodate multiple boards and commission schedules and responsibilities.

Your Committee discussed the preference for geographic and gender diversity across boards and commissions to provide an equal representation of voices and experiences throughout Maui County.

Your Committee noted the need for more diversity to fill the specialized seat requirements on the Board of Variances and Appeals and the Cost of Government Commission.

Your Committee expressed appreciation to the Mayor for the efforts put in to address these concerns, such as Board of Water Supply nominee Nichole Inouye-Nohara who, despite residing in Kihei, has experience in both the West and East Maui watershed areas.

Your Committee recommended 40 nominees be approved for the boards and terms for which they have been nominated and recommended Exhibit "B" to the resolutions be revised accordingly. Your Committee was satisfied with the background of the nominees and expressed its gratitude to the nominees for volunteering to serve the community.
