May I please request you be prepared to answer the following questions at the Budget, Finance, and Economic Development Committee meeting on **March 7, 2023**.


1. The LATCF allows the use of funds for "any governmental purpose other than a lobbying activity." How does your Department anticipate using these funds in Fiscal Year 2023?

The Department of the Treasury has indicated that any LATCF submission issues must be resolved by March 15, 2023. Will the Department be able to meet this deadline?
