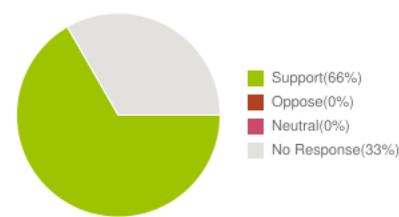

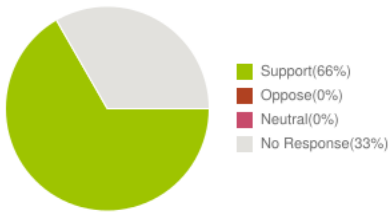

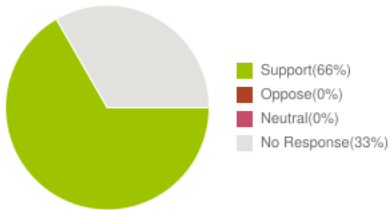

After selling over \$10,000 of produce last year with much hard work, I can proudly call myself a farmer. However I highly need help on my farm, to be successful, especially as I am aging! This is a win win for farm owner and farm help. I agree with testifier who said his farm is almost a charity and not financially viable; this bill would help. Thank you so much Autumn Ness for proposing this bill. I do think there should be some accountability re: proving one is actually farming to qualify for the ability to add more square footage to farm dwelling or add small units and that the folks in the increased dwelling space or units are legitimately helping out on the farm, to make sure the new spaces are not used for rentals to new main-landers who are not contributing on the land, or vacation rentals.
