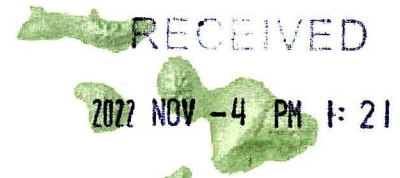
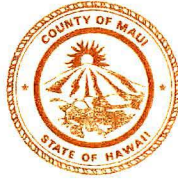

SUBJECT: **PROPOSED ORDINANCE AMENDING SECTION 2.82.050,  
MAUI COUNTY CODE, REGARDING THE GREENPRINT**

I am submitting a proposed ordinance entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 2.82.050, MAUI COUNTY CODE, RELATING TO GREENPRINT" for consideration at the next County Council meeting.

The purpose of the proposed ordinance is to amend the Conservation Planning Committee's timeline for developing, submitting and adopting the greenprint. The proposed date of submission is December 31, 2024.

The new timeline would support the Conservation Planning Committee in developing a robust plan and framework that recognizes the economic, social, environmental, and cultural benefits that parks, open space, agricultural and ranch lands, and conservation lands provide to the public. The Committee has initiated developing the project scope, identifying resources for consultant services, and discussing foundational components of this plan.

BILL NO. 197 (2022)

A BILL FOR AN ORDINANCE AMENDING SECTION 2.82.050,  
MAUI COUNTY CODE, RELATING TO GREENPRINT

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 2.82.050, Maui County Code, is amended to read as follows:

**"2.82.050 Greenprint.** Using public outreach, the general plan, and other community and documentary resources, including land conservation organizations, a comprehensive conservation plan, also known as a greenprint, must be created that includes a geographic information systems map. The greenprint will guide land acquisition by the County for open space, natural resources, cultural resources, and scenic views preservation purposes, and help to identify lands suitable for voluntary private-sector conservation. A proposed greenprint must be adopted by the committee and submitted to the council by [December 31, 2022.] December 31, 2024. The committee must oversee the review and update of the greenprint, which must be submitted to the council every five years."

SECTION 2. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring.


SECTION 3. This ordinance shall take effect upon its approval.
