4. Please describe the process DLNR follows to issue commercial boating permits. Please include references to applicable provisions, the cost to obtain a commercial permit, and the cost to transfer a commercial permit.

Please note that DLNR's statutory authority as well as the Hawaii Administrative Rules that pertain to commercial boating under DLNR are complicated and dense. In most cases (other than the cost to apply for a commercial use permit being \$25), the answers to the Committee's commercial boating permitting questions are not simple. Therefore to explain each sub question in writing would require lengthy copied language from the Hawaii Administrative Rules. Instead, we think it would be more helpful to simply cite to the appropriate Hawaii Revised Statute and/or Hawaii Administrative Rule.

The Hawaii Revised Statutes that gives DLNR the authority to issue commercial use permit can be found in Chapter 200, subchapters 200-3, 200-4, and 200-9.

The process to apply for a commercial use permit can be found in Hawaii Administrative Rules (HAR). Title 13, Subtitle 11, Ocean Recreation and Coastal Areas, Part 1, Small Boat Facilities and Provisions Applicable to all State Navigable Waters, HAR Title 13, Subtitle 11, Chapter 231, Subchapter 3 Operation of Boats, Small Boat Harbors, and Use Permits for all Navigable Water.

The cost to obtain a commercial Use Permit can be found in <u>HAR</u>, <u>Part I</u>, <u>Chapter 234</u>, <u>Subchapter 13-234-16</u>. The cost to apply for a commercial use permit is \$25.00.

The cost to transfer a commercial use permit can be found in HAR, Subchapters <u>13-234-33</u>. West Maui specific rules are in 13-256-7.
