

RELATING TO THE APPOINTMENT OF DUSTIN HAROLD
PŌMAIKA‘ILANI KALEIOPU TO THE LIQUOR CONTROL
ADJUDICATION BOARD FOR THE COUNTY OF MAUI

WHEREAS, by correspondence dated March 1, 2023, Mayor Richard T. Bissen, Jr. notified the Council that he nominated Dustin Harold Pōmaika‘ilani Kaleiupu to the Liquor Control Adjudication Board for a term expiring March 31, 2026, to fill a vacancy replacing Shane Dudoit, in accordance with Section 13-2, Revised Charter of the County of Maui (1983), as amended (“Charter”); and

WHEREAS, Charter Section 13-2 requires the Mayor’s nominee to be approved by the Council; and

WHEREAS, Charter Section 13-2(17) requires the Council to approve or disapprove the nomination within sixty days after the Mayor submits the name of the nominee to the Council; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it approves the appointment of Dustin Harold Pōmaika‘ilani Kaleiupu to serve on the Liquor Control Adjudication Board for a term expiring March 31, 2025;
2. That the Council expresses its gratitude and appreciation to Dustin Harold Pōmaika‘ilani Kaleiupu for his willingness to be considered for public service and actively participate in County government; and
3. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, and the Corporation Counsel.
