Response:

The status of the following projects funded by the Parks Assessment Fund in FY 2023 per Department of Parks and Recreation: CBS-3232 Countywide Park Playground Improvements: Consultant selection in process for all projects except One Alii Playground and Shade Structure. One Alii is in permitting and is awaiting approval from the Molokai Planning Commission.

CBS-5552 South Maui Beach Parks Parking Lots Improvements: Po'olenalena Beach Parking Lot Improvements is in design. Wailea Beach Parking Lot Improvements is in pre-construction (a construction contract has been awarded but the project has not started). Waipuilani Beach Park North is in design and permitting. Haycraft has been designed and permitted and is being posted for bid.

CBS-7242 Fifth Street Courts Resurfacing and Improvements: Consultant has been selected. We are awaiting a design fee proposal from the consultant.

CBS-7256 Lahaina Recreation Center Improvements: Consultant has been selected. We are awaiting a design fee proposal from the consultant.

CBS-6652 Napili Park Improvements: Project is in design and permitting. Project is expected to be posted for bid in late 2023.

The status of the following projects funded by the Parks Assessment Fund prior FY 2023 per Department of Parks and Recreation:

CBS-2345 South Maui Parks System, \$75,000: Construction on hold - permitting.

CBS-5534 Haiku Park Restroom, \$411,509.37: Construction start - 5/2023.

CBS-6652 Napili Park Improvement, \$84,479.10: Design in progress – bid late 2023).

CBS-3232 Countywide Park Playground Improvements, \$361,749: Construction start – 8/2023).

CBS-1118 South Maui Community Park, \$347,323.79: Design in progress. CBS-5483 Launiupolo Master Plan, \$500,000: Project on hold.

3. The balance of funds in the Affordable Housing Fund, specific to each residency area if applicable. Please also indicate if any of the residency area funds are to be used for a specific purpose.

Response: According to the Department of Finance, the current available balance in the Affordable Housing Fund is \$26.2 million. This balance reflects appropriations made in FY 2023 budget that have yet to be encumbered or expended.

The affordable housing fund does not have a specific residency area allocation. The Department of Housing and Human Concerns conducts a RFP each year and the proposals are scored competitively. The AHF does not require the Department to set aside an amount for each geographic/residency area.
