**Response:** The Department's proposed budget is made up of \$20,965,000 from the Highway

fund. The Highway fund allocation is 41.7% of the Department's budget including the General and Grant Revenue funds. However, if Grant Revenue funds are not included in the Department's total budget, the Highway funds would account for

62% of the Department's budget.

Question 2: Please provide the number of bus riders who transport a bicycle on the bus in a

given fiscal year. (TC)

**Response:** For calendar year 2022, there were a total of 5,260 boardings with a bicycle.
