

Overall Sentiment







Those experiences affirmed my deep yearning to move back home, to be near family, and to continue making art with and for the vibrant, ever-evolving Maui community that raised me.

One year after moving back, I was asked to join the artistic team as co-artistic director, and hope to perpetuate this company's mission to cultivate a space for high level contemporary dance work on Maui. As ADT comes up on its ten year anniversary, we strive to continue to bring compelling, meaningful dance work and educational programming to the diverse Maui community. We remain grounded in and inspired by our mission to bring Maui dancers home in hopes that someday, they too can envision moving back, knowing their artistic lives will flourish here. Aloha BFED Committee,

I hope you're familiar with Upcountry Strong, Inc. but in case you're not, I'd like to give you a quick update on our non-profit.

What started as a grass-roots effort between neighbors in Makawao to support our community during the pandemic, quickly turned into a movement. Established in 2020, Upcountry Strong, Inc. set out to address the issue of food insecurity faced by residents of Upcountry Maui during the Covid-19 pandemic. The areas served include Makawao, Pukalani, Haliimaile, Kula, Ulupalakua, Haiku, Paia, and all the way to Hana. _

While our initial efforts were a direct response to the pandemic, we quickly became aware that the issue of food insecurity was not new to our community. The need is on-going and we are committed to try and continue our food support efforts but we face the challenge of sustaining these efforts due to the lack of financial resources.

To date, we've had 17 food distributions at Oskie Rice Arena and have fed over 3,400 families with approximately 85,000 pounds of food including fresh meat, fresh produce, and non-perishable items.

During the pandemic, much of the supplies were donated from The Maui Food Bank, Haleakala Ranch, and various other businesses. Unfortunately, this is no longer the case and we are left to purchase most of the items that we provide in our food boxes. Thankfully we are able to purchase the items at cost but each event is roughly costing us a minimum of \$5,200. With our current budget, we've had to adjust from our usual (8-9) events to now only (6). Our current finances just barely be able to fulfill these (6) events planned for 2023.

I wanted to share the information below to give you an idea of the typical beneficiaries of the program:

Here's a breakdown of recipients by area/age from our February 2023 distribution:

96768 & 96788-over 65% 96790-14.9% 96708-13.2% 96779 & 96713-small portion adults served (18+)-469 children served (under 18)-285 Just a couple notes to point out:

We had 76 new registrations at the last distribution in February.

We are seeing an increase in our Kupuna at these distributions.



This is in line with our mission: "Maui Search and Rescue is a 100% volunteer organization dedicated to providing free expert search and rescue assistance and community outreach education." We believe a strong sense of community starts at home and extends out to the people of Maui, both residents and visitors alike.

Background

MSAR was launched in response to the disappearance of Charli Scott, a pregnant young woman, who was reported missing from Haiku in February 2014. In the days immediately following her disappearance an overwhelming public response followed. It became clear that an organized community-based search and rescue organization was needed in Maui County to complement and support the official efforts of police and fire departments. MSAR members were there to coordinate volunteer search teams and K9 teams, disseminate information about the searches, and serve as a liaison between members of the family, police, fire, media and the public.

Today

MSAR currently has 18 active human members and has trained over 60 participant members since 2014. All members are screened with a county and federal background check. Members complete a 40-hour training course including 2 classroom sessions conducted weekday evenings and 4 field sessions conducted on weekends. Field personnel must pass a Backcountry Physical Test which includes hiking the equivalent of 3 miles in rough terrain in less than 1.5 hours while carrying a pack that is 20% of their body weight. All field and some support roles are required to pass three online FEMA courses and CPR & First Aid certifications. Membership skills include urban and field search, swiftwater and ropes search, intake interview, and radio operations.

MSAR has 4 active dogs (K9s) who are in constant training for specialties including tracking, trailing, air scenting, and human remains detection (HRD).

Our members purchase their own personal equipment package consisting of several sets of weather and climate appropriate clothing and utility gear costing approximately \$1,500. Our members come from all professions and backgrounds including education, legal and construction and we are pleased to have a representative cross-section of Maui giving back to the community by helping to search for missing and lost people.

On average MSAR has responded to 5-6 incidents per year. Responses may range from Intake (interview, gather & share information with agencies) to Preliminary Search to full Callout.

Agency Cooperation

MSAR supports MEMA in providing a unified response to emergencies in Maui County. MSAR works in cooperation and communication with Maui police and fire departments. To better formalize this relationship, MSAR is in the process of meeting with the Maui Police Department (MPD) to determine a Memorandum of Understanding (MOU) and intends to do the same with Maui Fire Department. MOUs with these departments will assist in widespread inter-department, inter-agency recognition to facilitate the sharing of information and resources when responding to a missing person event. Each agency brings both unique and overlapping skills to a response scenario. For example, MSAR interviews with family may garner different/additional information if anyone has a reluctance to discuss matters with uniformed officers. MSAR members are trained and versed in intensive ground searches in areas that may not be as accessible to some other agency personnel. Maui and MEMA need all resources available during emergencies and MSAR brings additional capabilities to this cooperative body.

RE: 2024 Maui County Budget – Animal Management

Mahalo to the Council for your accomplishments in the 2023 budget. Council can take pride in adjusting real property tax rates to reflect the impact non-owner occupied investment properties have in fueling price increases. I would welcome your consideration of additional rate increases for this class of ownership.

Another area I think should be addressed through the budget is The Animal Management program administered by the Maui Humane Society.

Program Management

The important issue not addressed in their funding request is how do they achieve a humane animal management program in an island ecology where established invasive species and disease are slowly obliterating the natural environment. The record shows MHS can do well at adoptions, enforcing animal cruelty law and picking up strays. Recently they have initiated efforts at providing support for pet owners in need to reduce the number of pets arriving at MHS for adoption. All activities most would support. But there is a serious conflict of goals when it comes to managing invasive pet species.

Specifically, MHS is wed to the Mainland policy of Trap, Neuter, Return (TNR) for outdoor cats. On its present course TNR results in an ever increasing outdoor cat population while continuing the destruction of our endemic species. TNR proponents always promise an "eventual" reduction of feral numbers "sometime" in the future. The reality is TNR facilitates a warehousing of unwanted pets both at MHS and spread throughout the island in the form of neighborhood and rural cat colonies. Consequently, these colonies continuously grow the population by attracting abandoned and feral animals to groups where they then mate and provide us with an unending wave of new cats to care for. Program sponsored spay and neuter activity has no chance of keeping up with the pace of newborns.

MHS TNR-centric enforcement policies promote the growth of outdoor cat populations. MHS will not remove an outdoor cat from one of these colonies unless they have been totally abandoned. Because the enforcement standard is based on providing food and requires no evidence by a colony sponsor of spay or neuter, or requiring surrender of newborn kittens for adoption, or any other restrictions, these neighborhood colonies flourish. If one sponsor moves on, the cats stay put and integrate into other neighborhood colonies or find new sponsors. And the process begins all over again at their new address introducing a new set of neighbors to daily yard cleanup of cat feces, cat spray on the front door, dead birds and more. Similar situations exist for the numerous feeding stations sponsored and maintained by various online organizations.

Just this morning I saw an article about feral feeding stations on Hawaii Island attracting Nene. Luckily the DLNR got involved to get agreement from the property owner to remove them because of their risk to endangered endemic wildlife. *And they repeated their plea to protect the environment by keeping all cats indoors*. Contrast DLNR actions with MHS non-action and we can see the conflicting goals of

preserving our island ecology vs supporting invasive species encroachment promoted as a "humane" policy.

Because of the ecological threat they pose to the island there is no place on Maui for free roaming cats. I agree we need to be humane in how outdoor cat numbers are reduced but we need to start the process of reducing these numbers now.

Program Cost



The cost of using MHS as the contractor for animal management has proven increasingly expensive. A \$1.7m budget in 2019 doubled to \$3.6m by 2021, fell back during Covid, and then resumed growing with yet another increase to \$3.4 million requested in the 2024 budget. If Maui could claim to have a program that aligned with the budget goal of protection of the environment and the strategic vision of an environmentally responsible

and sustainable community then I would not have to write this. But our Animal Management program is an example of good intentions with no accountability and no end to funding increases that costs much more than county citizens should be paying.

Animal Management Track Record

Looking at the MHS performance against some of the Goals and Actions that have been in the budget the longest do little to indicate animal management is improving. Compared to the most recent actual performance (2022) three of the six line items are budgeted for improvement while *three items, LRR Dogs, Volunteer Hours and Spays and Neuters are budgeted to get worse*.

The largest positive gainer (1,000% vs 2019) by far is "Outreach" to 900,000 people reached. With an island population of 170,000 that is a questionable achievement. If the justification of pursuing still

higher outreach numbers is that it generates more support for efforts locally then why don't other goals related to volunteers and adoptions show an upward trend?

Bottom Line – Maui County pays a lot for a program that does not align with the ecology of the island, overarching budget goals and the County's strategic vision.

Some Intial Steps Council Can Consider to Improve Animal Management of Outdoor Cats

- 1) Add a continuing budget goal of provable outdoor cat reductions.
 - a) Establish an accurate population number for outdoor cats
 - i) Take an actual count or provide estimates based on reliable sampling information.
 - b) Provide an annual target for outdoor cat population reduction
 - c) Use historically close connections with local online groups that maintain feeding stations to capture and adopt out outdoor cats.
 - i) If adoption is not sufficient or suitable to absorb these remote colonies then consider alternatives such as shipping to the mainland Humane Society.
- 2) Reduce or Hold Flat County budget support until progress on reductions is established.
 - a) It is counterproductive to approve any amounts for facilities expansion or increased operating expenses resulting from policies not consistent with a healthy and sustainable Island ecology. The last two AM budgets for Sheltering and Enforcement (+90% of total AM budget) have grown at a 13% compound annual rate. Since 2019 the total AM budget has grown on a similar pace. In 6 years the budget will be over \$6 million if allowed to continue.
 - i) Approve a flat or reduced budget until progress is shown.
 - (1) Because TNR leads to increased outdoor populations (spays and neuters never keep up with new abandons and births) require MHS to motivate their donation base to provide support for the increased needs from a policy that isn't appropriate for Maui.
 - (2) Last year HARF received a one time \$250k funding for its facilities in the budget. The current MHS budget request converts this one time expense to an annual recurring expense by absorbing it into requested increases for various contractual costs. In effect the one time HARF grant is converted to funding part of the MHS budget expansion.
 - (3) Seeing they are excellent at outreach, MHS should be expected to rely on motivating its donation base to offset the majority of their requested increases.
- 3) Redirect MHS enforcement practices to reducing the number of outdoor cats
 - a) Current MHS enforcement practices lack any element directed to population control and in practice encourage an ever growing number of free roaming cats.
 - b) Instead of being solely focused on TNR in pure form MHS should pivot to aggressively discourage the prevailing notion that anyone who wants a colony of outdoor cats can have one with their support.

Doubling funding over the last six years hasn't led to improved metrics. There is no plan to reduce the cost to taxpayers of an agency that traditionally relied on donations for financial support. The current cat management policy leads only to increased numbers and increasing budgets. All in the name of a policy singularly focused on humane cat treatment at the expense of endemic wildlife and a healthy environment.

A ban on outdoor feeding would solve a lot of these problems. But new laws are hard work and take much time and effort. We don't have to wait for new laws. We need a change in direction from MHS. We must insist MHS adopt their methods and policies to our needs, not the other way around. Because of disease, predators and climate change our island is an environment where several native birds are on virtual life support or extinction. Some state agencies have been forced to use heroic measures to salvage a very small population at best. How can we in good conscience fund efforts based on supporting invasive species that by their nature makes saving endemic species more difficult?

There was a news article last August announcing a project by MHS to count outdoor cats. It was a rare moment of encouragement for those of us who feel the cat problem has remained hidden behind a successful PR campaign of TNR advocacy. But since then nothing has been announced and I don't see anything in the budget request for financial support. I fear that small first step has been shelved. Perhaps the realization of the enormity of the problem has led to second thoughts.
