SUBJECT: FISCAL YEAR ("FY") 2024 BUDGET (BFED-1) (MD-3)

Thank you for your letter dated April 10, 2023 regarding the Fiscal Year 2024 budget for the Department of Management. Please see the below responses:

1. Please provide information on possible business improvement district boards that can provide security or cleaning services to districts or towns. (YLS)

Response:

At this time, the County of Maui does not have any Business Improvement Districts, or Special Improvement Districts as they are defined in the Maui County Code 3.70. Chapter 3.70 outlines a process for creating and operating a Special Improvement District. This process largely mirrors the process for a Business Improvement District on the U.S. continent and around the world.

In the Urban Land Institute's reference book titled, Business Improvement Districts, Second Edition, author Paul R. Levy writes:

Despite many differences in their details, all BIDs are fundamentally a legal mechanism to raise funds to enhance the management of a particular place. Bradley Segal, a Denver-based consultant who has helped organize many BIDs offers the following definition: "A BID is based upon the benefit district concept, which allows for an assessment of property within a defined geographic boundary. Revenues from this assessment are directed back to the defined area to finance a myriad of enhanced services, including security, maintenance, marketing, economic development, parking and special events." While BIDs in North America are usually funded by an assessment on real property, often times some additional support provided by the municipality is provided.

In recent years, BIDs have become the preferred mechanism in business districts to allow the property and business owners to direct programming and services as needed. The Department of Management has been tracking this trend and participating in international discussions and trainings to learn more.

2. How much was paid to use ground penetrating radar consultant services, per project, in FY 2023? (SS)

Response:

The Department of Management retained Ground Penetrating Radar (GPR) services for the Wailuku Civic Complex and for the Hālau of 'Ōiwi Art at a cost of \$48,000 to date. Department of Environmental Management has used GPR for a leach field in Hana Ball Park for Helene Hall. Department of Parks and Recreation will likely also utilize GPR in upcoming projects.

3. Would the Department support the creation of a Maui County veteran's board or council? (GJ)

Response:

The Department would first encourage the categorizing of existing veterans' resources, boards, etc., promote the education and dissemination of that information for awareness, and then identify any gaps that may exist under the current resources in place, so as to ensure no duplication of services, programs or advisory boards and that the entities with the appropriate personnel, resources and legal authority are at the table to serve our veterans.

As brief examples, Maui County veterans are served by the University of Hawaii at Maui College's Veterans Resource Center, United States Department of Veterans

Affairs' Maui Vet Center, Veterans Affairs Pacific Islands Health Care System, State of Hawaii Office of Veterans Services, Advisory Board on Veterans' Services, Maui County Veterans Council, etc.

4. Please provide an itemized cost breakdown for each Clean and Safe Program in FY 2023. (NUH)

Response:

The Lahaina, Wailuku and Paia contracts each include approximately \$155,000 annually for salries and wages for administration, daily safety consultation and patrols, dispatch and reporting. However, in recent months, safety concerns have increased and sometimes two safety ambassadors are necessary for certain shifts, increasing this base cost. In all three contracts a homeless outreach social worker was budgetted for \$72,900 per year. Those positions remain unfilled and unbilled. In Wailuku Town the contract also includes approximately \$32,000 in salaries and wages for the Mental Health Kokua cleaning team and the native plant caretakers as well as \$45,000 in subcontracts for dumpster service, landscape mainteinance and power washing. All three contracts utilize Lokahi Pacific as a fiscal sponsor, who charges an 11% fee for bookkeeping and oversight.

5. Please provide the next steps for the Affordable Housing project on Lāna'i. (GJ)

Response:

The Department of Managment will coordinate with the Department of Housing and Human Concerns to retain a consultant for the purposes of developing a design-build Request for Proposals for the Lāna'i Affordable Housing project.

6. Please provide information on plans to address abandoned vehicles located on County property. (TP)

Response:

In regards to specific County properties that have a seen a considerable buildup of abandoned vehicles over the past several years, we will work in a collaboration with other departments to include the Office of Innovations, Dept of Housing and Human Concerns, Public Works, Maui Police Department and the Department of Environmental Management. Currently, we are conducting and assessment of MP#14 area of Honoapiilani Hwy and will begin an orderly removal of abandoned vehicles. Our goal is to remove any abandoned vehicle which is located and identified to be on County property.

7. Regarding the reorganization of the Information Technology Services Division, of the 17 vacant positions, please identify which ones require 12-months funding and which do not. (TP)

Response:

All 17 vacant positions will need full funding to cover costs for the entire year. Paperwork has been completed for all vacant positions and submitted to DPS for final review. ITSD is hoping for reorganization approval in the next couple of months. This will cover positions impacted by the reorganization, all other positions are posted as active recruitments.

8. Please provide a corrected page 745 for CBS-2789, Wailuku Civic Hub, that doesn't include \$11,000,000 in Federal funds intended for the Halau of 'Oiwi Arts. (KRF)

Response:

Please see attached.

9. Please explain why no CIP page was included for CBS-7251, Halau of 'Oiwi Arts. Is it because additional funding for FY 2024 is not necessary? (KRF)

Response:

No additional funding is being requested in FY 2024 for the Hālau of 'Ōiwi Art.

- 10. The following questions relate to CBS-6651, 60 South Church Street Building Renovations: (KRF)
 - a. Please provide details on how the expended or encumbered amount of \$995,729 reported in FY 2023 has increased to \$10,245,641.

Response:

The amount of \$995,729 was encumbered in 2021-2022 for design services (\$964,729) and County data network infrastructure (\$31,000). (NOTE: this amount includes monies that were encumbered prior to creation of CBS-6651 in the FY 2022 Budget. The correct number that should have been reported in FY 2023 Budget as "Prior Years Expended/Encumbered" for CBS-6651 is \$735,729). Between that time and the time of the current budget request submission, an additional \$131,000 was encumbered for design services, and the construction contract was awarded in the amount of \$9,378,912.

b. Please explain why the FY 2023 Budget projected no funds for this project

in FY 2024, yet the proposed FY 2024 Budget includes \$3,900,000 in funding.

Response:

The FY 2023 Budget request was made during the early stages of design for the building renovations, therefore, it was based on early cost estimates of a limited scope of work. As design progressed during 2022, the scope of required renovation work grew, leading to higher cost estimates. Much of the expanded scope items had to be excluded from the construction contract due to the winning bid exceeding available budget. However, the bid provided an actual cost for the excluded scope items which was helpful in formulating the FY 2024 Budget request. Furthermore, the construction contract was executed with no contingency monies, so they have also been included as part of the \$3,900,000 FY 2024 Budget request.

c. Is \$14,955,641 the total amount for renovations the County anticipates expending for this project or has the amount exceeded the original estimate?

Response:

The County anticipates expending a total of \$14,210,000 for renovations under CBS-6651.



PROJECT DESCRIPTION

Construction of a Multi-Use Facility at the site of the Wailuku Municipal Parking Lot. The previous expenditures at the site are being utilized to fund a revised design secure permits, update environmental documents, and obtain approvals required for construction as well as acquisition of key parcels. The program for construction includes the following parameters for design:

1) A parking facility that accommodates 300 or more parking stalls with a portion of the parking to be created sub-grade or partially sub-grade. Parking facilities should have minimum 10 foot ceiling heights. Above grade portion of the facility should be designed to double as a special events space such as farmers markets, swap meets, etc. The portion of the parking between Main and Pili Street shall not exceed 28 feet above existing grade at the mauka property line.

2) A plaza, community gathering and performance space will be developed on Vineyard Street. This outdoor gathering space would support uses in the civic center and could be programmed for events and equipped to accommodate various size performances.

3) The plan and construction will accommodate logistical details including trash collection, deliveries, staging, grease trap placement, utilities connections etc.

4) FY 2024 funding covers the budget shortfall due to discovery of burials, hiring additional archaeological monitors, ground penetrating radar services, change in excavation methodology and redesign.

PROJECT JUSTIFICATION

The facility will provide needed parking during peak periods within the Wailuku Redevelopment Area. During non-peak times, it will double as a special event space and expand the economic viability of the area as an Arts and Entertainment district, therefore stabilizing and expanding the tax base.
