Pursuant to your correspondence dated April 20, 2023, the following are responses to your questions.

1. How much funding will Molokai S.T.E.M. Robotics receive in FY 2023? (KRF)

2. When is the Salary Commission anticipated to determine the East Maui Water Authority Director's salary? (TC)

This was discussed by the Salary Commission in March. They are scheduled to continue to discuss this in May and intend to use the Department of Agriculture as a model.

3. Page 402 of the Program Budget states one of the duties and

functions of the Office of Innovation will be to coordinate actions and policies of County departments to increase community resilience and preparedness dedicating resources to advance equity for disproportionately impacted communities. How do you interpret this statement? (TK)

The Office of Innovation and Sustainability's interpretation of the statement, "to coordinate actions and policies of County departments to increase community resilience and preparedness dedicating resources to advance equity for disproportionately impacted communities" means to partner with County departments (e.g. DHHC, DEM, DWS, DPR, etc.) to take collective actions that benefit those that are directly and most negatively affected due to their socioeconomic and environmental conditions. There is demographic and location-based data that helps inform which communities are most at risk from the aforementioned.

According to a Dec 8, 2022 Maui News report on poverty in Hawai'i, "52% of Maui County homes live below the ALICE threshold." Of those, "Native Hawaiian and Filipino residents are more likely to be living below the ALICE threshold... the report shows a growing divide in Hawai'i between those living comfortably and those trying to survive financially, especially affecting Hawaiian and Pacific Islander households, female-led households, and households with children."

OIS advocates for better outcomes in areas facing disproportionate environmental and health ills, typically minority and low-income communities. Our Kauhale and bridge housing initiatives strive to provide an alternative housing and community resource for those most at-risk. Likewise, OIS coordinates with the Four County Sustainability Network (4CSN) and is active on the Hawai'i Executive Conference Climate Coalition, as well as engaging in Hawai'is Voluntary Local Review on Sustainability, and improving on and implementing the CARP. The energy savings measures undertaken through our Johnson Controls contract will reduce the County's overhead expenses and increase resiliency. Also, our focus on integrated water and water conservation systems, eventual electrification of the County fleet, food sovereignty, and supporting numerous conservation programs and projects through our grants all work to build resiliency throughout the many communities across Maui Nui.

The Climate Crisis is already one of the greatest threats facing humanity and, unfortunately it will define and shape our everyday life like no other. This is why it is critical for us to pursue and implement these objectives.

4. Page 3 of Appendix B-1, County of Maui Concession/Lease/License Schedule – By Departments, shows the base rent of \$4,200 for Ke Kula 'O Pi'ilani. Will that rate continue in perpetuity? If not, when will it expire? (TP)

The 5th Amendment to Lease with Hawaii Nature Center dated 7/1/22 extended the lease until 07/31/23. Ke Kula O Pi'ilani is in the process of applying for a Grant of County Property with OED.

5. The previous Planning Director proposed a 10 percent increase in the Department's rates and fees to be consistent with Section 3.01.020, Maui County Code. Why was this proposed increase not reflected in the FY 2024 Budget? (TP)

The proposed 10 percent increase submitted by the previous director was inadvertently left out of the FY 2024 budget and was an unintentional oversight.

6. Under the Technology in Business Promotion line item, can a conditional request of \$65,000 for Lana'i Entrepreneur Assistance be added without increasing the total funding amount?? (YLS)

Yes.

7. Please explain why Habitat for Humanity Maui did not receive the \$89,000 in funding for Housing and Urban Development certified housing and counseling services. (TP)

Habitat for Humanity's request for this funding was received well after the Department's budget proposal was completed in the Fall of 2022. The agency was informed of this timing issue and that the Mayor would ultimately make the decision to add this request to the budget or not.

8. Would the Administration be willing to allocate funds for a feasibility study for affordable housing on Lana'i? (GJ)

The administration needs more time to discuss allocating funds for this request.

9. Please explain the difference in grant funding between the \$2.25 million transferred to the Department of Agriculture and the \$1.31 million under the Economic Development Program - Grants and disbursements for Agricultural Promotion listed in the FY 2023 Budget. (KRF)

Per Councilmember Rawlins-Fernandez, on the April 22, 2022 BFED meeting, it was noted that for the \$2,250,000 Agriculture Promotion/Technology (Index code 923012B-Sub Object Index Code 6317), \$1,310,000 of this fund is for the following agricultural groups:

Hawai'i Taro Farm, Farm Bureau, CTAHR, and Moloka'i and Lāna'i Ag Promotion.

No information of how much money for each group was noted. It will be up to Department of Agriculture to determine grant funding allotted to each group.

10. Please provide a list of new and existing Workforce Development Programs proposed using General Funds. Please confirm that the Workforce Innovation and Opportunity Act funding would not cover these programs. (YLS)

WIOA funds are only used for WIOA WFD salaries and WFD project partners like Goodwill Industries and American Job Center. See attached spreadsheet "Attachment 2" which shows how our OED grants funded several workforce development projects from other organizations.

Aloha Council Members,

We received an urgent request from Office of Economic Development to respond to your question on the expenditures for the Molokai Proviso. Please note that MEDB does not take any administrative fees of charge any staff salary to the \$75,000 Proviso, nor is any penny of it spent on any other island students. All of it goes to direct services for Molokai public schools' students, teachers, and programs. Also, not all of the funding is used for robotics, the proviso is for Molokai STEM Education and we try to distribute the funding broadly and responsively to the requests from Molokai teaches. We are currently spending FY23 money, which MEDB's grant does not end until September 30, 2023, so some of the proviso funds will be spent for Molokai summer interns' stipends at \$1,800 each.

Total to date is \$84,222, exceeding Proviso by \$9,222, which MEDB is pleased to pay from other competitive grants. Molokai teachers and students also participate in MEDB's STEMworks professional development and sponsored programs in GIS, Computer Science, the Engineering Design Process, Clean Energy, 3-D printing, AI, Virtual Reality, Healthcare career exploration, Creative Media, Minecraft, and project-based learning throughout the year, paid for by MEDB's other competitive federal, state, and private sector grants, which significantly leverages the County's investment. The MEDB team members were deeply concerned when there was a misperception expressed that MEDB spent a portion of the Proviso on other islands. We are honored to be the stewards of the proviso and work to ensure it goes directly to the Molokai public school students benefit! Your organization, MAUI ECONOMIC DEVELOPMENT BOARD for your Stemworks Afterschool program has been included in the FY2024 Mayor's Proposed Budget to the County Council in the amount of \$225,000.00.

STEMworks AFTERschool, has adapted the project-based learning and design-thinking processes used in MEDB's in-school STEMworks labs into the after-school space, intercession breaks, and summer for Middle School and Elementary students. Most of this funding is used to pay the teachers, using Department of Education set hourly rates, for their time outside school hours. Students learn coding, robotics, game-design, 3-D printing, how to work in teams, the engineering-design process, access to industry professionals to learn about career pathways, and entrepreneurship. This is a critical age to keep students engaged in meaningful activities, to help avert challenges in the future. We propose to serve 700 students.
