AUTHORIZING SETTLEMENT OF ONO GELATO OF PAIA, LLC V. COUNTY OF MAUI, CIVIL 2CCV-22-0000258

WHEREAS, Ono Gelato of Paia, LLC filed a lawsuit in the Second Circuit Court of the State of Hawai'i on November 4, 2022, Civil 2CCV-22-0000258, against the County of Maui for negligent misrepresentation and nondisclosure, tortious interference with business relations, violation of due process and equal protection, and unequal enforcement of law and to recover economic losses located at 115 Hāna Highway, Unit D, Pā'ia, Hawai'i; and

WHEREAS, the County of Maui, to avoid incurring expenses and the uncertainty of a judicial determination of the parties' respective rights and liabilities, will attempt to reach a resolution of this case by way of a negotiated settlement or Offer of Judgment; and

WHEREAS, the Department of the Corporation Counsel has requested authority to settle this case under the terms stated in an executive meeting before the Government Relations, Ethics, and Transparency Committee; and WHEREAS, Section 3.16.020(B), Maui County Code, requires Council authorization for any settlement of claims or civil litigation in excess of \$7,500; and

WHEREAS, having reviewed the facts and circumstances regarding this case and being advised of attempts to reach resolution of this case by way of a negotiated settlement or Offer of Judgment by the Department of the Corporation Counsel, the Council wishes to authorize settlement; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

- That, under Section 3.16.020(B), Maui County Code, it approves settlement of <u>Ono Gelato of Paia, LLC v. County of</u> <u>Maui</u>, Civil 2CCV-22-0000258, under the terms stated in an executive meeting before the Government Relations, Ethics, and Transparency Committee;
- 2. That it authorizes the Mayor to execute a Release and Settlement Agreement on behalf of the County in this case;
- That it authorizes the Director of Finance to satisfy settlement of this case; and

 That certified copies of this Resolution be transmitted to the Mayor, the Director of Finance, the Planning Director, and the Corporation Counsel.
