WHEREAS, the Charter amendment on Maui County Community Water Authorities and the East Maui Regional Community Board, proposed by Resolution 22-119, CD1, FD2, was approved at the 2022 General Election; and

WHEREAS, the Charter amendment establishes the 11-member East Maui Regional Community Board, with seven members appointed by the Council by resolution and four appointed by the Mayor, with various qualifications and initial terms; and

WHEREAS, the Council, through its committee, has recruited and vetted East Maui Regional Community Board applicants; and

WHEREAS, the persons listed in Exhibit “A” submitted an application for a seat on the East Maui Regional Community Board or were recommended by the Department of Hawaiian Home Lands for the seat that represents the Hawaiian Homes Commission; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it approves the appointment of the persons listed in Exhibit “B” as members of the East Maui Regional Community Board, for terms beginning on the date of this Resolution’s certification by the County Clerk;
2. That the Council expresses its gratitude and appreciation to all applicants for their willingness to be considered for public service and actively participate in County government; and
3. That certified copies of this Resolution be transmitted to the Mayor; Managing Director; Director of Water Supply; Corporation Counsel; Kali Watson, Chairman, Hawaiian Homes Commission; and each of the Council’s appointed members to the East Maui Regional Community Board.
