Chair and Members:

Your Water and Infrastructure Committee, having met on May 26, 2023, makes reference to Bill 35 (2023), entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 3.44.015, MAUI COUNTY CODE, RELATING TO QUARTERLY REPORTS ON THE ACQUISITION AND DISPOSITION OF REAL PROPERTY."

Bill 35's purpose is to require the Director of Finance to submit quarterly reports to the Council instead of within five days of any acquisition or conveyance of real property.

Your Committee notes that the requirement for reports within five days was mandated by Ordinance 4274 (2015).

The Director of Finance said issuing reports on a quarterly basis would allow more flexibility for the Department.

Your Committee voted 8-0 to recommend passage of Bill 35 (2023) on first reading. Committee Chair Cook, Vice-Chair Sugimura, and members Johnson, Lee, Paltin, Rawlins-Fernandez, Sinenci, and U'u-Hodgins voted "aye." Committee member Kama was excused.

A BILL FOR AN ORDINANCE AMENDING SECTION 3.44.015, MAUI COUNTY CODE, RELATING TO QUARTERLY REPORTS ON THE ACQUISITION AND DISPOSITION OF REAL PROPERTY

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Subsection H of section 3.44.015, Maui County Code, is amended to read as follows:

"H. The director must [notify] <u>advise</u> the council [in] <u>by</u> <u>written quarterly report</u> [writing] of any acquisition or conveyance made [in accordance with] <u>under</u> this section that does not require council approval. The [notice] <u>report</u> must include a map of [the] <u>each parcel of</u> real property or easement acquired or conveyed[, and must be submitted no later than five days after the date the acquisition or conveyance is completed.] <u>during the reporting period.</u>"

SECTION 2. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring.

SECTION 3. This ordinance shall take effect upon it approval.
