

#### **Overall Sentiment**









The Council recently approved an FY2014 budget that increased taxes by \$129 million over last year and \$214 million over the taxes it collected in FY2022. This two-year tax increase amounts to an increase of 53% above the taxes it collected in FY2022. Maui County has far more money than it can responsibly and effectively spend.
