Chair and Members:

Your Government Relations, Ethics, and Transparency Committee, having met on October 17, 2023, makes reference to Resolution 23-113, entitled "AUTHORIZING SETTLEMENT OF CLAIM NO. 4076130 OF HANSEN OHANA SECURITY LLC (ROBERT HANSEN)."

Resolution 23-113's purpose is to authorize settlement of the claim, filed on March 30, 2022, in the amount of \$14,982.67. The claim alleges damages to the claimant's property located at 52 Kuli Pu'u Street, Kīhei, Maui, Hawai'i, resulting from a water main break.

By correspondence dated March 13, 2023, the Department of the Corporation Counsel provided a copy of the claim.

Your Committee notes Section 3.16.020(B), Maui County Code, requires Council authorization for any settlement of claims or civil litigation in excess of \$7,500.

A Deputy Corporation Counsel provided an overview of the claim and explained that the parties had reached a negotiated settlement, pending Council approval.

Based on information received and the recommendation of the Department, your Committee voted 8-0 to recommend adoption of Resolution 23-113. Committee Chair U'u-Hodgins, Vice-Chair Paltin, and members Cook, Johnson, Kama, Lee, Rawlins-Fernandez, and Sinenci voted "aye." Committee member Sugimura was excused.
