Some concerns you should consider when reviewing the proposed County Wellhead Protection ordinance.

Wellhead Protection Overlay District ("WPOD").

The WOPD's are established based on one computer model study done via the UH. The study had only one peer review for its accuracy or reliability. Yet, the DWS is basing the County **Wellhead Protection Overlay Districts** in the ordinance on such a poorly reviewed or verifiably accurate study.

Prohibited uses of property in WPOD Zone B

1. New cesspools, 2. Electrical/electronic manufacturing facility, 3. Mortuaries/graveyards.

4. Golf courses, 5. Metal plating/finishing/fabricating facility, 6. Chemical processing/storage facility, 7. Plastics/synthetic production facility 8. Junk/scrap/salvage yard 9. Construction of new highways/freeways, 10. Mines 11. Landfills/dumps, 12. Injection wells/dry wells/sumps.

13. Artificial recharge projects (non-potable water) 14. Reclaimed wastewater irrigation class R2 and R3, 15. Sewage sludge land application, 16. Slaughterhouses, 17. Wastewater percolation ponds.

What if you have one of these uses already on your property now when it becomes designated in Zone B?
