Pursuant to the July 10, 2018 Water Resources Committee meeting to discuss a revised proposed resolution entitled, "REFERRING TO THE MAUI, MOLOKAI, AND LANAI PLANNING COMMISSIONS A PROPOSED BILL AMENDING TITLE 19, MAUI COUNTY CODE, RELATING TO WELLHEAD PROTECTION OVERLAY DISTRICT," DWS staff acknowledges the discrepancies to Appendix C, WPOD maps, of the subject proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING TITLE 19, MAUI COUNTY CODE, TO ESTABLISH A WELLHEAD PROTECTION OVERLAY DISTRICT".

As per your request, please find attached the revised Appendix C with corrected WPOD maps for your review. Changes include:

- Removed all private wells outside of delineated wellhead protection overlay districts.
- 2. A new ESRI topographical basemap.
- 3. Updated TMK parcels data from 2017.
- 4. A legend item added for the red lines ("MAJOR ROADS").
- 5. Removed "DRAFT" from all maps.

"By Water All Things Find Life"

A total of four individual maps required specific changes on the basis of new, revised capture zone data from the USGS and updated wells data from the DWS. These include the following:


- 1. WPOD Map 3: Added Kanoa 2 Well. Used new capture zones layer provided by Bob Whittier (USGS). The spelling "KAHAKALOA" was corrected to "KAHAKULOA".
- 2. WPOD Map 4: Updated capture zone layers provided by DOH which reflects new pump rates for existing wells Waihee 1, 2 and 3, and Waiehu Heights 2.
- 3. WPOD Map 5: Updated capture zone layers which includes Wailuku Well 1 and Wailuku Well 2, and the revised pump rates for lao Tank Site, Waikapu Tank Site, Mokuahu 1 and 3, and the removal of Shaft 33.
- 4. WPOD Map 8: Added well "Wakiu C" and used new capture zones layers.

KOPE GULCH TO IAO STREAM, MAUI


