In response to the Budget, Finance and Economic Development (BFED) Committee letter dated September 3, 2024 regarding COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG): GRANT CANCELLATIONS AND REPROGRAMMING OF FUNDS (BFED-21(11)), please find the re-stated BFED question followed by the formal response of the CDBG Program Office as follows:

BFED QUESTION:

May I please request you provide a status update on the property management contract for the condominium units, including whether any of the units are occupied. For any unit not yet occupied, explain why the unit is not occupied and when you expect it will be occupied.

RESPONSE:

The terms of the property management Contract and Scope of Work for the Na Hale Kupuna Units have been defined and agreed upon by the Department of Corporation Counsel, the CDBG Program Office and the proposed property management company. Contract execution will occur upon proof of insurance that shall be provided by the property management company.

The property management company anticipates that they will advertise, receive applications and offer the units to CDBG eligible persons within 30 days of contract execution.

BFED QUESTION:

May I please also request you provide any updates you have regarding CDBG Disaster Recovery funds for the County of Maui.

RESPONSE:

The County of Maui has not received formal notification of a supplemental, Congressional CDBG Disaster Recovery appropriation at this time.
