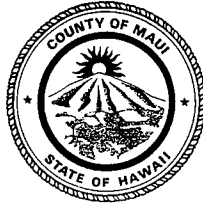

Dear Mayor Alan Arakawa,


Thank you for appointing me to the Cost of Government Commission in 2014. It has been a valuable learning experience, giving me great insight and respect for our local county government.
