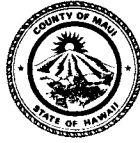

SUBJECT: REQUESTS FROM APRIL 13, 2016 MEETING
(PR-6) (BF-1)

At its meeting of April 13, 2016, the Budget and Finance Committee requested your Department's responses to the following requests:

1. Provide an itemized list of projects for CBS-1117, Countywide Parks Americans with Disabilities Act Improvements for Fiscal Year 2017. Include the project title, description, and estimated cost. (RH)
2. For projects proposed at the Waiehu Golf Course, indicate whether the expenditures should be made from the Golf Fund. Please explain. (RH)
3. What other large-scale repaving projects has the County recently completed which are similar in scope to the work needed for the War Memorial Complex repaving project? Provide project details such as total material costs, total labor costs, size of project, date of project, contractor name, type of funds used, project timeframe, and project district, and compare those project details with the proposed War Memorial Complex repaving project. 4. Provide an aerial diagram of the property on which the Waikapu Community Center is located, identified for real property tax purposes as Tax Map Key (2) 3-5-010:035 (portion). Provide options on how the Center and adjacent parking lot can be reconfigured on the property to maximize use of the land, while taking into account

the existing locations of the baseball field, basketball court, and comfort stations. (RH)
