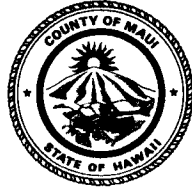


As you have requested at its meeting on April 5, 2016, the Budget and Finance Committee requested our Department's responses to the following requests/questions:
