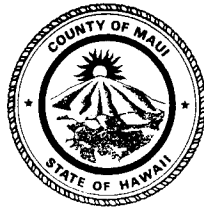

SUBJECT: FISCAL YEAR ("FY") 2017 BUDGET (BF-1)

At its meeting of March 30, 2016, the Salary Commission voted to approve salary increases for the First Deputy Prosecutor in the Office of the Prosecuting Attorney and the First Deputy Corporation Counsel in the Office of the Corporation Counsel to be effective July 1, 2016.

The action by the Commission resulted in an increase of \$6,353 from \$114,353 to \$120,706 for both the First Deputy Prosecutor and the First Deputy Corporation Counsel.

Please note that due to the timing of the Salary Commission's decision, these increases are not reflected in the FY 2017 Mayor's Proposed Budget.
