SUBJECT: REQUESTS FROM APRIL 11, 2016 MEETING (PR-5) (BF-1)

This is in response to your letter dated April 13, 2016 requesting the Department to respond to requests from the Budget and Finance Committee's meeting of April 11, 2016.

1. Provide a priority list of County parks, by district, to be addressed with Capital Improvement Project funds in Fiscal Year ("FY") 2017. Explain why the list of parks was prioritized this way. (RH)

Attachment #1 - Priority List

The projects were prioritized for each district in a consensus between the district facility manager, Division Heads, and Director's office based on the most urgent need and the project's readiness for bidding.

2. Provide warranty information on the toilet trailers your Department is requesting to purchase. Include the following: 1) when warranty will commence, 2) length of warranty, 3) covered parts and equipment, 4) items not covered, 5) how warranty service will be provided, if necessary. Address limitation of the warranty as it relates to external factors, such as salt air, in combination with the proposed locations of the trailers. (RH)

Attachment #2 - A.M.S. Global, Inc.'s Limited Warranty Program

- 1) Warranty commences upon acceptance of delivery.
- 2) Length of warranty is 1 (one) year.

- 3) All parts and equipment are covered.
- 4) Vandalism is not covered by the warranty.
- 5) Warranty service is provided by contacting the manufacturer. Manufacturer contracts a local vendor to correct the issue.
- 6) The trailer toilets are made of corrosion resistant metals and composite materials; therefore, are suitable for harsh climates, with proper maintenance.
- 3. Provide a list of list of completed and ongoing Capital Improvement Projects, by district and fund, for FY 2015 and 2016, to date. If the project has been completed, include the completion date, the total amount of funds appropriated, and total amount of funds used. If the project has not yet been completed, explain the reasons for the delay, and the expected date of completion. (SC)

Parcels (2) 1-4-004:003 and (2) 1-4-004:033, 2 (two) acres toward the north end of the complex are owned in fee simple by the County of Maui. Parcels (2) 1-4-004:030 and (2) 1-4-004:028, 2.739 acres toward the south end of the complex, are owned by the State of Hawaii and under Executive Order No. 3084 for "Community Center Purposes" to the County of Maui.

- 6. Provide a list of every type of recreational component (i.e., drag strip, dirt track circle, motocross track, go-cart track, etc.) at the Maui Raceway Park Complex ("Park"). Include a list of the predominant user groups of the Park. (DG)

7. Which program or division within your Department is responsible for oversight of the Park? (DG)

The Recreation & Support Services, South District oversees this park.

8. Provide a breakdown of County expenditures over the past five years related to operations and maintenance of the Park. Also, provide a list of improvements made to the Park that were funded by the County and the cost for each improvement. (DG)

C4841 with Maui Kupono Builders Maui Raceway Park Drag Strip Resurfacing \$286,474.30 Encumbered in FY2011 Final Payment January 2012

9. Provide a breakdown of improvements made to the Park that were funded by outside sources (i.e., user groups, the State, private donations, etc.) and the cost of each improvement. (DG)

There have been no substantial improvements the last 5 years except for routine maintenance from the Park Caretakers which includes weed whacking and rubbish pickups twice a week.

10. Identify the provisions of the Maui County Code and administrative rules that govern the use of the Park. If no such provisions exist, describe your Department's policy for use of the Park. (DG)

All our parks are governed by the Maui County Code Title 13 including Maui Raceway Park. Over the years these groups have been allowed to make improvements to their specific sites with County approval.

11. What is the status of a long-range plan for the Park? (DG)

The Department of Planning is finalizing the Pu'unene Master Plan Update: A Plan for the Maui Motorsport Park at Pulehunui, Maui. The purpose of the study was to update the 1995 Master Plan (Puunene Airport Area Master Plan - MEO Transportation Facility) prepared by Helber Hastert.

Since that time, there have been several significant changes such as the construction of the Air National Guard base. The proposed master plan includes three sections: description of existing conditions, an overall vision and concept for the site, and recommendations organized by function.

Upon the master plan's finalization, it will be sent to the State of Hawaii Board of Land and Natural Resources (BLNR) for review and approval. Subsequent to the State master plan approval, the Department of Parks and Recreation will submit for approval to BLNR and the Maui County Council, the proposed user leases in their designated areas as defined in the plan.

12. What means are available for user groups to participate in, contribute towards, or initiate maintenance activities or improvements for the particular facilities they use within the Park? (DG)

Currently, the Maui Motorsport Park user groups obtain annual parks permits. As indicated in number eleven above, it is our department's intent to obtain the necessary approvals for the user group leases. Subsequent the approval and execution of the user group leases, they will be able to contribute towards and initiate maintenance activities or improvements for their particular leased areas.

13. What is the status of the \$2 million FY 2016-2017 State appropriation to the County for the Park to repave portions of track and ancillary roads; rebuild a concrete launch pad; replace restrooms; and purchase improved timing, lighting, and maintenance equipment? (DG)

The \$2 million FY 2016-2017 State appropriation to the County is still being discussed on a department level to determine the scope and priority of work for the site. The department anticipates being able to summarize this scope and hold meetings with all of the current permitted user groups by October of 2016 to firm up the specific scope of these funds.

14. Explain why the \$2 million FY 2016-2017 State appropriation to the County is not identified in the County's FY 2017 Budget. (DG)

These monies are not identified in the FY2017 Budget because their plan for expenditures is still being solidified. Once completed, the department will work with the Budget Office to encumber the funds through a budget amendment, contract, and the State's encumbrance process by the June 30, 2018 State deadline.



Executive Order No. 3084

Setting Aside Land for Public Purposes

By this Executive Order. I, the undersigned, Covernor of the State of Hawaii, by virtue of the authority in me vested by Section 171-11, Hawaii Revised Statutes, and every other authority me hereunto enabling, do hereby order that the public land hereinafter described be, and the same is, hereby set aside for the following public purposes:

FOR COMMUNITY CENTER PURPOSES, to be under the control and management of the County of Maui, being designated for the establishment of the Hana Community Center, containing an approximate area of 1.889 acres, more or less, for Parcel 1, 1.266 acres, more or less, for Parcel 2, and 37,029 square feet, more or less, for Parcel 3, being formerly portions of the Old Hana School Site and Garden Lots, said property being more particularly described in Exhibit "A" and delineated on Exhibit "B", both of which are attached hereto and made parts hereof, said exhibits being respectively, a survey description and survey map prepared by the Survey Division, Department of Accounting and General Services, State of Hawaii, both being designated C.S.F. No. 19,189 and dated June 13, 1981.

SUBJECT to disapproval by the legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.



By this Executive Order, J. the undersigned. Governor of the State of Namail, by virtue of the authority in me vested by Section 171-11, Hawaii Revised Statutes, and every other authority me hereunto enabling, do hereby order that the public land hereinafter described be, and the same is, hereby set aside for the following public purposes:

FOR COMMUNITY CENTER PURPOSES, to be under the control and management of the County of Maui, being designated for the establishment of the Hana Community Center, containing an approximate area of 1.889 acres, more or less, for Parcel 1, 1.266 acres, more or less, for Parcel 2, and 37,029 square feet, more or less, for Parcel 3, being formerly portions of the Old Hana School Site and Garden Lots, said property being more particularly described in Exhibit "A" and delineated on Exhibit "B", both of which are attached hereto and made parts hereof, said exhibits being respectively, a survey description and survey map prepared by the Survey Division, Department of Accounting and General Services, State of Hawaii, both being designated C.S.F. No. 19,189 and dated June 13, 1981.

SUBJECT to disapproval by the legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.
