Retirements result in the loss of Police Officers with more than 25 years of experience. Although retirements average about 14 Police Officer annually during the past three years, we hired 37 Police Officers during the same period. Thus, the hiring and training is a perpetual, anticipated process. Since the SHOPO pay rates are based on years of service, there is a significant difference in pay between those retiring and their replacement, but the impact is insignificant due to the relatively low number of annual retirement – less than 5% of our authorized staffing.
