SUBJECT: FISCAL YEAR ("FY") 2017 BUDGET (PR-9) (BF-1)

This is in response to your letter dated April 17, 2016 requesting the Department to provide information on Commercial Ocean Recreational Activity permits ("permit").

1. Is there a limit to the number of permits issued in a fiscal year? Is there currently a waitlist of applicants wanting permits? Please explain.

Currently we are in excess of the maximum number of permits allowed in Subchapter 4 of the enclosed Rules of Practice and Procedure for Commercial Ocean Recreational Activity Permits that were adopted in August 2009. As depicted by the enclosed CORA Permits Report by Activity & Park, there should be a maximum total of ninety-five (95) CORA permits issued. However, as evident by the enclosed 2015 CORA Applicants listing, we issued 108 permits for FY2016. Additionally, although no official waitlist has been generated, the Department has periodically received a few requests for CORA permits by new applicants.

2. Can permits be issued at any time during a fiscal year? If so, is the permit fee prorated for the portion of the fiscal year the permit is held? Please explain.

The Department generally does not issue permits outside of the designated renewal processing period for the upcoming year. Pursuant to the Rules of Practice and Procedure for Commercial Ocean Recreational Activity Permits, CORA permits have a duration of up to one year and the Director may renew a permit for additional one-year periods. In addition, the description of the CORA application fee and subsequent permit fees in the annual budget ordinance does not indicate the allowance of fee proration. Should the Department issue a new permit mid-way through the fiscal year, the applicant would still be required to pay the full amount of fees.

3. Are permittees allowed to sublease their permits? If so, are there restrictions on the way permittees must calculate the cost to sublease permits? Is there a limit to the number of permits a permittee can sublease? Is this activity monitored by your Department? Please explain.

CORA permittees are not allowed to sublease their permits. This is in accordance with Section 10-102-9 Non-transferability of permits of the Rules of Practice and Procedure for Commercial Ocean Recreational Activity Permits. In addition, 13.04.300 – Non-transferability also states that permits shall be nontransferable. The Rangers of the Department's Permit and Enforcement section monitor for possible violations of this activity.

4. Is there a limit to the number of permits issued per permittee? Please explain.

There is no limit to the number of permits that can be issued per permittee provided the Department receives a complete CORA permit application, all additional required documents and payment of the applicable fees. However, due to the existing number of issued CORA permits being in excess of the maximum number allowed in Subchapter 4 of the Rules of Practice and Procedure for Commercial Ocean Recreational Activity, the Department limits the number of permits issued to an applicant to the number that the applicant has held in the previous fiscal year.

5. List the County beach parks where commercial ocean recreational activity is allowed.

Enclosed with this letter are copies of a 2015 CORA applicants listing and a chart titled as CORA Permits Report by Activity & Park. These documents list the beach parks where commercial ocean recreational activity is allowed and are based on Subchapter 4 of the Rules of Practice and Procedure for Commercial Ocean Recreational Activity Permits. In addition, while Article X. Commercial Ocean Recreational Activity in Title 13 of the Maui County Code does not specify which County beach parks allow CORA, it does provide a list of prohibited locations. The list of these beach parks, as described in Section 13.04.256 include the following locations: Baldwin Beach Park, Cove Park, Hookipa Beach Park, Kamaole Beach Park II, Kamaole Beach Park III, the southern portion of Kalama Park, Launiupoko Beach Park and Puamana Beach Park.

6. Explain the renewal process for permits. Do permittees follow the same process to renew a permit as they did when they initially applied for a permit? Please explain.

For the most part, applicants who are renewing their previously issued CORA permits for a new fiscal year would follow the same process to renew a permit as they did when they initially applied for a permit. The permit application process includes the completion and submission of the enclosed application packet and additional documents described within, payment of both a CORA non-refundable application processing fee and a non-refundable park/activity-specific CORA permit fee. However, only with permit renewals would applicants need to submit the enclosed Commercial Ocean Recreation Activity (CORA) Annual Permit Report Form, item H in the application packet, as it refers to participation and accident/incident counts for the previous fiscal year.
