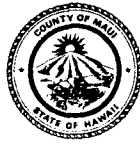

3. Explain the rationale for all of the reallocations of positions to Housing Specialists. (RH)
4. Explain why there is no request to fill position HC-0097, Information/Publicity Technician for Kaunoa Senior Center. (MW)
5. Explain why there is no request for a list of eligible applicants for position HC-0096, Senior Services Program Specialist III for Kaunoa Senior Center. (MW)

6. Provide a list of initiatives for the Early Childhood Program. (MW)
7. Provide, electronically, all the applications received in response to a request for proposals for grant funding for FY 2017. (EC)
8. Explain why your Department does not use the services of Ka Lima O Maui, Ltd. for ground maintenance at Departmental facilities. (RH)
