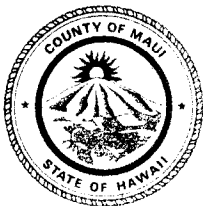


**SUBJECT: REQUESTS/QUESTIONS FROM THE APRIL 21, 2016 MEETING

There is no Master Plan that was completed for the 209 acre Central Maui Regional Park, but the Master Plan for the 100 acre Waikapu Baseyards does consider the 209 acres Central Maui Regional Park in its site planning and analysis.MD-3 BF-1


