Aloha Chair Takitani and Members of the Committee on County Governance,

At the March 31, 2016 meeting I attended, a question was raised by Committee Member Jonathan Starr. As I understand the question, it was "How many of the department directors I appointed, worked on my election campaign?"

Many talented persons volunteer to work on political campaigns and if an individual or individuals who do work on a campaign are **qualified** to serve, there should be no prohibition to their applying for and being selected as a director of a department or any other appointed position.

In my particular case, I can report that of the 11 (eleven) department directors I appointed, only one worked on my campaign and in a relatively minor role. Three directors worked for the previous administration. Three (3) of the eleven (11) that I appointed were confirmed by the Maui County Council as required by the Charter of the County of Maui.

During the course of my term, two directors resigned and were replaced. The new directors I appointed had not worked on my campaign.

I regret that I am unable to be on Maui today for the meeting. I had assumed that I could participate by phone, but find that doesn't seem to be an option.

As you know I voted in opposition to the change in our county government structure. I did submit my comments in an earlier written document to the committee, so I won't go in to those reasons here.

I looked over the TIG document very carefully. Only option 3 would be acceptable to me. If the group is truly committed to having a county manager form of government, then we must do away with the Mayor. It makes no economic sense to have a paid Mayor with his staff when they are simply ceremonial. The County Council Chairperson can serve as the ceremonial head of the County.

Charter Questions for Special Committee

- 1. If there is a vacancy on the council, and the unexpired term is less than fifteen months, and the council fails to fill the vacancy, should the Mayor or the Managing Director appoint someone, or should the Mayor or Managing Director fill the vacancy? (Section 3-4(1))
- 2. After an election, until a Council Chair is chosen at the organizational meeting, should the Mayor or the Managing Director preside? (Section 3-5)
- 3. Should the managing director weigh in on all bills prior to Council's passage to discuss implementation, enforcement, and possible budget amendments? (Section 4-2)
- 4. Who shall be the interim Mayor if there is a vacancy and if the unexpired term is less than one year? Currently it falls to the Managing Director, then to the Director of Finance. (Section 7-6)
- 5. Who should determine the Managing Director's salary? The Salary Commission? Council approval of contractual agreement? (Chapter 17)
