Dear Councilmember Victorino,

Thank you for bringing the proposed Maui Charter amendments to our attention. Although our office will not be taking a position on the matter at this time, we believe there is a possibility that the proposed amendments, if ratified, could be vulnerable to legal challenges on First Amendment and due process grounds. After conducting preliminary research into the ability of public employers to restrict employees' political speech conducted in the employees' personal capacity, we believe that the Council may wish to consider the following:

- 1. The Council may wish to further clarify, in both proposed amendments, exactly which types of speech/activity are prohibited.
- 2. The Council may wish to ensure that the phrase "political contributions" is clearly defined by the Hawaii elections statute.
- 3. The Council may wish to provide evidence as to exactly why such restrictions are necessary.


