RESOLUTION ADOPTED BY THE BOARD OF DIRECTORS OF
MAUI MEADOWS NEIGHBORHOOD ASSOCIATION ("ASSOCIATION")

RESOLVED, the Association supports the democratic right of the People to decide by popular vote on the November 2016 ballot whether the following change to Maui County's charter should be approved as recommended by the Maui County Special Committee on Governance at its meeting on May 9, 2016:

"Shall the Charter be amended to establish a revised structure of governance for the County of Maui wherein:

A Managing Director, appointed by the County Council shall be responsible for the County's daily operations, the appointment and removal of department heads, and the implementation of County policy; and an elected Mayor shall be responsible for representing the County in intergovernmental affairs, with the authority to approve or veto bills, and nominate board and commission members?"

FURTHER RESOLVED, Members of the Maui County Council are urged take all steps necessary to ensure the above matter is placed on the ballot and before the voters in November and that all committee and council meetings and hearings preliminary to doing so will be undertaken expeditiously, timely and without exception.
