Chair and Members:

Your Policy and Intergovernmental Affairs Committee, having met on July 11, 2016, makes reference to County Communication 15-5, from Councilmember Mike White, relating to nominations to boards, committees, and commissions.

By correspondence dated and received June 22, 2016, the Mayor transmitted a proposed resolution, entitled "RELATING TO THE APPOINTMENT OF SHARON SUZUKI TO THE CIVIL SERVICE COMMISSION," along with a completed application form for the nominee.

The purpose of the proposed resolution is to approve or disapprove the appointment of Sharon Suzuki to the Civil Service Commission, for a term expiring on March 31, 2020, to fill a vacancy due to the resignation of Ivy Waller.

Your Committee notes general appointment procedures for the Commission are provided in Section 13-2, Revised Charter of the County of Maui (1983), as amended, and Chapter 2.41, Maui County Code. Specific provisions for the Commission are contained in Charter Section 8-9.4, and Sections 76-47 and 76-71, Hawaii Revised Statutes.

Your Committee further notes the Council has until August 21, 2016, to approve or disapprove the Mayor's nominee, or the nominee shall be deemed appointed.

In an interview with your Committee, Ms. Suzuki stated she is committed to attending Commission meetings and fulfilling her duties on

the Commission, which would include fairly considering County employee compensation issues.

Your Committee noted Ms. Suzuki's experience as a business leader would be helpful to the Commission, which is responsible for adopting rules to carry out the provisions of the civil service laws of the State.

Your Committee expressed its appreciation for Ms. Suzuki's willingness to serve on the Commission.

Your Committee voted 7-0 to recommend adoption of the proposed resolution. Committee Chair Victorino and members Baisa, Carroll, Cochran, Crivello, Hokama, and White voted "aye." Committee Vice-Chair Couch and member Guzman were excused.

Your Committee is in receipt of a revised proposed resolution, approved as to form and legality by the Department of the Corporation Counsel, incorporating nonsubstantive revisions.

Your Policy and Intergovernmental Affairs Committee RECOMMENDS that Resolution ______, attached hereto, entitled "RELATING TO THE APPOINTMENT OF SHARON SUZUKI TO THE CIVIL SERVICE COMMISSION," be ADOPTED.

- 2. That the Council expresses its gratitude and appreciation to Sharon Suzuki for her willingness to be considered for public service and actively participate in County government; and
- 3. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, and the Corporation Counsel.
