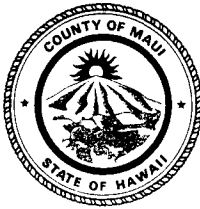

WHEREAS, by correspondence dated July 15, 2016, Mayor Alan M. Arakawa notified the Council he nominated Michael "Kaleo" Ropa to the Maui County Cultural Resources Commission for a term expiring on March 31, 2020, to fill a vacancy replacing Mikala Enfield, pursuant to Sections 2.40.110 and 2.88.030, Maui County Code, and Section 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and


WHEREAS, Charter Section 13-2, requires the Mayor's nominee to be approved by the Council; and

BE IT RESOLVED by the Council of the County of Maui:

1. That it approves the appointment of Michael "Kaleo" Ropa to serve on the Maui County Cultural Resources Commission for a term expiring March 31, 2020;
2. That the Council expresses its gratitude and appreciation to Michael "Kaleo" Ropa for his willingness to be considered for public service and actively participate in County government; and
3. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, and the Corporation Counsel.

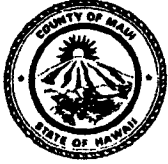
