SUBJECT: AMENDMENTS TO THE FISCAL YEAR 2017 BUDGET

On behalf of the Department of Police, I am transmitting a proposed bill entitled. "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2017 BUDGET FOR THE COUNTY OF MAULAS IT PERTAINS TO APPENDIX C - CAPITAL IMPROVEMENT PROJECTS, DEPARTMENT OF POLICE, COUNTYWIDE. COUNTYWIDE POLICE FACILITIES."

The purpose of the proposed bill is to add the project, Improvements to the Wailuku Police Station Records and Evidence Room, to Appendix C. Department of Police, Countywide Police Facilities.

This project was originally appropriated in FY 2015 under the Countywide Police Facilities project. However, the department was only able to partially complete the project with the funding available. The department is proposing to utilize unspent FY 2016 and current FY 2017 Countywide Police Facilities monies to complete the remainder of the project.

The Department of Police requests that this budget amendment be considered as soon as possible. I respectfully request that this matter be referred to the appropriate Council committee for expeditious review, discussion and appropriate action.
